2. COMPOSITION / INFORMATION ON INGREDIENTS

Contains: A mixture of anionic and non-ionic surfactants, wax, cellulose ether and preservative.

3. HAZARDS IDENTIFICATION

Main hazards: No significant hazard.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be mild irritation at the site of contact.
