2. COMPOSITION / INFORMATION ON INGREDIENTS

Contains: Aqueous styrene - acrylic copolymer emulsion, plasticiser, inorganic extenders, associative thickeners, reinforcing fillers, coalescing solvent, surfactants and fungicide.

3. HAZARDS IDENTIFICATION

Main hazards: No significant hazard.
