Contains: Aqueous acrylic polymer emulsion, plasticiser, inorganic extenders, associative thickeners, reinforcing fillers, surfactants and fungicide.

3. HAZARDS IDENTIFICATION

Main hazards: No significant hazard.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be mild irritation at the site of contact.
