Section 4: First aid measures

4.1. Description of first aid measures

Skin contact: Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Transfer to hospital if there are burns or symptoms of poisoning.

Ingestion: Wash out mouth with water. Do not induce vomiting. Give 1 cup of water to drink every 10 minutes. Transfer to hospital as soon as possible.
